"The Critical Role of the School Librarian in Digital Citizenship Education" by Leslie

Preddy is a professional article published in the journal, *Knowledge Quest*, and is available

through ProQuest. In this article, Preddy defines digital citizenship and school librarians' role in

**Critique:** 

Focusing on the immediate need for digital citizenship education integration, Preddy

defines digital citizenship and school librarians' role of implementing and integrating this

instruction. She explains that digital citizenship refers to interacting with technology in a

responsible and appropriate manner, and that there is a pervasive assumption amongst educators

that because students have grown up in a digital age they find digital citizenship practices to be

innate. Through referencing her authority on the topic of digital citizenship and relatable,

personal experiences the author utilizes logos and pathos in supporting her assertion that there is an immediate need for direct instruction of digital citizenship and it is the school librarian's role to oversee this education.

Preddy builds her credibility through mentioning her professional experience as a school librarian, university professor, and AASL president. Further building her authority in her author's bio, the author lists several awards she has received for her role in school library media programs. Additionally, she has been asked to lead webinars and is a requested, frequent speaker at local, state, national, and international conferences and events.

The author's writing style and referenced, personal experiences with technology and her own children, make her article relatable and straightforward. Her referenced authority in her author's bio establishes Preddy as a credible source on the topic of digital citizenship, ultimately utilizing logos in supporting her assertions. Further substantiating her claims through pathos, Preddy speaks about her two children's hard learned lessons about the dangers in utilizing technology without advanced digital citizenship education.

In this article, Leslie Preddy successfully supports her assertion that it is imperative for librarians to integrate and enforce digital citizenship education in elementary, middle school, and high school libraries. She bolsters these claims through the strategic utilization of logos and pathos. This article should be recommended to all school librarians, as digital citizenship is a topic that should be at the forefront of all school library programs.
